Since last November, the general public has become aware of its capabilities (cf. the domain of education). It has led to ChatGPT's fame.

§ 7 the limits of LLMs

Not perfect:

"patina of truth" (veneer): <u>a semblance of</u> truth

A fabrication: quelque chose que l'on invente de toutes pièces (cf. a lie)

Outright (adjectif): complet. (adverbe : carrément)

- factual errors

rival firms: entreprises concurrentes

VOCAB : concurrent NOM : <u>rival</u>, <u>competitor</u> concurrent ADJ : rival



concurrence (économique) : competition (rivalry est possible mais moins courant)

HOW SCARED SHOULD WE BE?

§ 8 The sheer acceleration of the process has given rise to fear /raised concern (plus faible)

The <u>sheer</u> acceleration: l'accélération à elle seule, la simple acceleration (sheer est donc un exellent adjectif Has it <u>spun out of control</u>? Has it <u>escaped control</u>? <u>Hence: D'où</u> Note : mot de liaison très pratique (notamment en question Mines et synthèse car suivi d'une phrase elliptique, sans verbe) <u>Accuracy</u> : exactitude (<u>accurate</u> : exct Adj) Al may threaten the future of humanity itself: could bring human species to the brink of extinction

§9 The fear of machines stealing jobs is not new BUT it could this be different this time So far, man has always been able to switch to the jobs the machines couldn't do (OUR COMMENT: reminds us of creative destruction) Dislocation = <u>disruption</u> Demand <u>for</u> sth/sb <u>To be ruled out:</u> être exclu (abstrait : pour une idée, hypothèse, etc) S'utilise souvent à la forme négative : We shouldn't rule out this solution

§10-11 Figures about experts' fears and how realistic these fears are The text draws on a survey of some AI experts: to assess their concerns, maybe even their fears. Indeed the word "nightmare" is used To pose a risk: notez la collocation <u>To cause harm:</u> faire du mal The issue is hotly debated: ... est ardemment débattu / le sujet suscite de vifs débats (Note : utile en colles) To be dismissed (au sens abstrait) = to be ruled out: être exclu <u>Guesswork</u> (Uncountable): de simples conjectures/hypothèses

The worst fear ? Cause harm on a massive scale: Making viruses and poisons Elon Musk : may have a vested interest in a pause: Indeed, he may want his own AI startup to have time to <u>catch up</u> with the existing ones (cf. Open AI)

The problem is that a pause is unenforceable, ie. Difficult to enforce (difficile à faire appliquer) Rappel : <u>To enforce the law</u> : faire appliquer la loi
